## From the Desk of the Executive Director

I have always loved October! It signals somewhat of a respite from the heat of summer and the intense processing that our cyclical calendar in financial aid mandates. Students are in school, most of the aid is in place, FISAPs are filed and we can concentrate on the upcoming year when it all starts over again.

After weeks of meetings, the FLY team chose the month of September, which was designated as Louisiana's College Savings Month, to conduct their pilot presentations at Plaquemine High School, Broadmoor Middle School and several campuses of Delgado Community College. Now that the pilot presentations are complete, the FLY Team is in the process of assessing the effectiveness of their different resources for the various audiences. I am excited to see what their next steps will be in this process and will keep LOSFA LOOP readers abreast of the progress.

Mapping Your Future provides information and services in a neutral and non-commercial format for the ultimate benefit of students and families. Since 1996, Mapping Your Future has received a number of awards, including recognition for its excellence in content and innovation in technology services.

Mapping Your Future (www.MappingYourFuture.org) provides step-by-step instructions on career,

college planning and financial aid. In addition, the site offers Online Student Loan Counseling, money management information and tools and online customer service for schools and their students.

"Ms. Amrhein brings a wide range of experience in the financial aid industry and higher education, including leadership roles with several financial aid industry organizations and Louisiana State University," said Julie Kubisiak, chair of the Mapping Your Future board and executive director of Student Loans of North Dakota. "This experience and knowledge will be essential in helping guide the organization through the next several years, as the financial aid industry faces many changes with impending legislation."

Other board members include Steven Brooks, executive director of North Carolina State Education Student Loan Authority; Bruce Marks, director of Montana Guaranteed Student Loan Program; and William H. Hurry, Jr., executive director at Rhode Island Higher Education Assistance Authority.

## **TOPS** Academic Year expanded to include Spring Intersession

The Louisiana Student Financial Assistance Commission/Louisiana Tuition Trust Authority (LASFAC/LATTA) Executive Committee approved changes to the TOPS Academic Year at its September meeting. Retroactive to the 2008-2009 academic year, hours earned during the Spring Intersession can be used toward the 24 hours required for TOPS retention. All hours earned between the beginning of the Fall Semester or Term and the beginning of the Summer Semester or Term can be used toward the 24 hour annual requirement. This includes all intersessions, "mini-mesters". etc. held within that time frame. In order to count, the class must be completed before the beginning of the school's Summer Semester.

#### Changes for students in the military

Also, students who enter the armed forces on active duty within one year of high school graduation must now enroll as full time students in an eligible institution no later than the semester or term immediately after the one year anniversary of their separation from active duty to be eligible for a TOPS award. This becomes effective for the 2009-2010 (current) academic year.

# **Changes to START approved**

The Louisiana Student Financial Assistance Commission/Louisiana Tuition Trust Authority (LASFAC/LAT-TA) Executive Committee approved rule changes to allow START account owners to leave their existing investments in total equities, while selecting a new option for new investments. This has the effect of allowing the account owner to have multiple options in the START program.

Also approved was a special exception to the program prohibition of partial refunds from accounts. Any withdrawal from an account that is not used to pay Qualified Higher Education Expenses is considered a refund. Currently, an account owner can close an account and withdraw the total value of the account. In such a case, the earnings are subject to both state and federal income taxes and a federal penalty if the funds are not rolled over to another 529 program. The account owner also forfeits any Earnings Enhancements and the interest thereon.

The rule change will allow account owners greater flexibility in managing their accounts by allowing account owners to make partial withdrawals for the sole purpose of rolling the funds over to another START account which is owned by the same owner, so long as the beneficiary of the second account is a member of the family of the beneficiary of the first account.

## 2009 LOSFA Professional School Counselor Workshops scheduled

LOSFA's annual Professional School Counselor Workshops have been scheduled and any school counselor who has not yet registered is encouraged to do so.

Counselors may register late after October 2, but those who do so will not receive an updated information binder on the day of the workshop. Binders will be mailed afterward to anyone who registers late.

This year, LOSFA is combining the Middle School and High School workshops. The workshops will be focused on program updates.
