### From the Desk of the Executive Director





# **LOSFA unveils new Award System**

LOSFA has migrated to a Web-based application system that will serve users of all LOSFA administered scholarships and grants programs, including TOPS, Go Grant, Early Start, TOPS Tech Early Start, Rockefeller State Wildlife Scholarship and Chafee Educational Training Voucher. Students and schools logging into their accounts via the Awards System now have access to a plethora of new information.

The Award System has a "new look and feel," Alice T. Brown, LOSFA IT Director, said. The move to the new system was spurred by a desire for "an easier way to support more scholarship and grant programs," she said.

LOSFA is rolling out the new system in three stages. By the end of September, the entire system will be in place. The new system will provide multiple benefits to students, schools, organizations and LOSFA personnel. Those benefits include:

#### Students:

- ► Earlier access to the Web site instead of being created with the FAFSA, logon ability created with first ACT record
- ► Home page information includes all eligible scholarships/grants
- ► Ability to electronically create an Exception Request (will still have to mail in supporting documentation) and review its status and associated comments. Additional information provided to assist students with filing the correct paperwork with the Exception Request
- ▶Notifications with PDF document that duplicates the letter sent via mail
- ▶ Ability to view approved payments to schools
- ► Access to Loan information via Meteor
- ▶ Real-time access to data and the ability to update mailing address and email address

#### Colleges:

- ► Ability to post broadcast messages
- Individual logon ids and passwords with group account management at the colleges
- ► Additional rosters (e.g., Grade error report)
- ►Access to student profiles including eligible awards and notifications
- ►Access to enter and view data for LEAP/SLEAP, Chafee and Rockefeller
- ► Access to Loan information via Meteor
- ▶Real-time access to data

#### **Board of Regents:**

► Access to HCELP information

#### Internal LOSFA User Groups:

- ►Improved system navigation
- ► Ability to track all name changes for a student
- ► Ability to view the application like the colleges or students
- ►Improved system reporting
- ▶Improved processing of ROOS applications no longer waiting week to week for processing updates
- ▶Improved processing of Grade records no longer waiting week to week for processing updates
- ▶ Provision of scholarship/grant student information across various programs with the ability to incorporate later Start and Loan data
- ►Integrated Exception processing with approval automatically creating Academic Information (e.g., Grade) to be used in renewal processing
- ►Easier process to create refunds

- ► Ability to group organizations (e.g., high schools, colleges)
- ►Clear processing history use of an audit log

# Simplified FAFSA

The federal government is planning additional changes to the Free Application for Federal Student Aid (FAF-SA) for the 2011-2012 academic year to make it even easier for students and parents to apply for financial aid.

The proposed changes include application status, PIN status, access to the previous year's information, information on who has updated the application and a Data Release Number for third parties.

Beginning January 30, 2011, the IRS Data Retrieval Tool will be available for Tax Year 2010. It will only be available to those who have completed a tax form. The parent's PIN will be used to link to the parent's IRS information. If income data is transferred from the IRS and the student is selected for verification, the verification will not include income information.

Beginning with the 2011-2012 Application, IRS Data Retrieval will be available for corrections as well as initial FAFSA submissions. Additionally, the IRS Data Retrieval Tool will be available in Spanish.

Seen a few new faces around and wondered who they were? Wonder no more! LOSFA's two newest employees are happy to meet you.






