### From the Desk of the Executive Director

The United States Department of Agriculture reported last year that it now costs an average middleincome American family \$222,360 to raise a child from birth to 18. That's 22% higher than it was in 1960, adjusted for inflation. When you take into account the sluggish economy and the fact that this dollar figure does not include college costs, it's understandable why some Louisiana residents may feel that saving money for college is simply not possible. The fact that we have TOPS, the premier merit-based scholarship in the country, leads some parents to believe that saving for college is not only impossible, but is actually unnecessary. We have to periodically remind parents of two important facts. First and foremost, TOPS does not cover all college costs so it's still important to save if you can. Lastly, in addition to having the premier merit based scholarship in the country, Louisiana also has the best 529 college savings plan, the START Saving Program. The existence of START is one of several factors that Governor Bobby Jindal cited as a reason for officially proclaiming September 2011 as College Savings Month in the State of Louisiana. Other reasons mentioned were the fact that rising costs of higher education have outpaced inflation and nearly four out of ten parents of college-bound children are not putting money aside for college. LOSFA plans to actively participate in College Savings month by launching a statewide media tour to raise the level of awareness of the importance of saving for college, how to save even during difficult economic times and the benefits of the START Saving Program.

This September, I would be remiss if I did not reflect on the fact that September 11, 2011 is the 10th anniversary of the attacks on the World Trade Centers in New York, NY. I know we all remember where we were that day as we learned or watched the surreal events happening in New York, Washington D.C. and Pennsylvania. Our world changed tremendously that day and its effects still shape our views of safety, security, heroism and patriotism. It is fitting that this anniversary falls on Sunday, to give us the time to truly reflect and pray, remember and pay tribute to the victims and heroes of that fateful day. I hope you all make time to remember them in a special way.

### **LOSFA attends LACRAO workshops**

Representatives from LOSFA attended Louisiana Association of Collegiate Registrars and Admissions Officers (LACRAO) workshops across the state last month, sharing information about LOSFA programs with high school counselors.

### Giftofcollege.com not authorized to accept START deposits

If you've been scanning the Internet and have come across GiftofCollege.com, be warned -- the site is not authorized to accept deposits for the START Saving plan.

GiftofCollege.com claims to collect money from credit cards and deposit those funds into 529 plans for its members. It says that anyone can donate via the site, for a fee. However, the College Savings Plans Network (CSPN), an affiliate of the National Association of State Treasurers, has sent a cease and desist letter to the site asking it to stop accepting contributions on behalf of any 529 Plan accounts.



According to CSPN, "To our knowledge, none of the 529 Plans listed on your Web site has authorized Gift of College, Inc., to accept contributions or solicit investments in 529 Plan products."

GiftofCollege.com is not authorized to accept deposits for the START Saving Program. START does not guarantee that money charged to the account owner's credit cards by GiftofCollege.com will actually be deposited into START accounts.

Further, LOSFA charges no fee to make deposits into a START Saving account. Deposits may be mailed directly to the program administrator at: Louisiana START Saving Program, PO Box 91271, Baton Rouge, Louisiana 70821-9271. Deposits may also be made by Electronic Funds Transfer from your personal savings or checking account or by employer deductions from your paycheck.

### TOPS Opportunity Award qualfiying ACT remains 20

The minimum ACT score necessary to qualify for the TOPS Opportunity Award remains at 20 for the upcoming year.

The 2011 ACT state average composite score this year was 20.2.

### Test your savings knowledge

Unsure of how easy it is to save for college? LOSFA's here to help!

### **State Matching Funds Grant**

Because federal LEAP and SLEAP funding has been eliminated for the 2011-2012 academic year, state matching funds in the amount of \$1,000,000 that would normally have supplemented the Federal LEAP Program have been allocated to eligible schools to be used as need-based aid. This need-based aid program has been named the State Matching Funds Grant. The allocations to each school are based on the percentage equivalent to the amount of LEAP funding received during 2010-2011.

### School Eligibility

In order to receive funds, schools must have:

- ▶ Received LEAP funding during the 2011 Academic Year;
- ▶ Utilized the full allocation from the 2011 Academic Year, and
- ► Satisfied the reporting requirements for the 2011 Academic Year.

#### Student Eligibility

The student eligibility criteria for the State Matching Funds Grant will be the same as previously used for LEAP. Students must have substantial financial need. For the purposes of this program, substantial financial need is defined as "the difference between the student's cost of attendance and the sum of that student's expected family contribution (EFC), plus other student aid the student is due to receive. The difference thus computed must exceed \$199." PLEASE NOTE: Emphasis must be on awarding students with the greatest amount of unmet need.

#### **Award Amount**

There is no minimum award, but the maximum annual award remains at \$2,000.

#### **Reporting Requirement**

As with the LEAP/SLEAP Programs, all schools receiving funds will be required to submit recipient rosters to LOSFA by the March 15 reporting deadline. The data previously reported for LEAP (student name, SSN, income level, dependency status, award amount) will be required in addition to the following new data: Pell Grant amount and remaining unmet need after Pell has been awarded.

Modifications to the Award System are currently underway and instructions for submitting this data, as well as a revised batch file layout, will be forwarded to schools as soon as the modifications are complete.

### START Maximum Allowable Account Balance

Effective August 1, 2011, the START Saving Program's Maximum Allowable Account Balance (MAAB) per beneficiary is \$280,420.

This amount is per beneficiary. The total balance in all accounts for the beneficiary cannot exceed \$280,420. Once the account reaches this amount, START must return future deposits until the MAAB increases.

Governor proclaims September as College Savings Month

LOSFA launches statewide media tour in support of the START Saving program

Governor Bobby Jindal has proclaimed September as College Savings Month in Louisiana.

To raise awareness of the state's 529 college saving program, the Student Tuition Assistance and Revenue Trust (START) Saving Program, a statewide media tour is being organized by the program's administering agency, the Louisiana Office of Student Financial Assistance (LOSFA).

In issuing the proclamation, Jindal urged families and employers to "recognize the benefit of attaining a higher education and to begin saving for their children's education." He added, "government at both the federal and state levels, needs to encourage saving versus consumption and assisting rather than hindering parents, grandparents, friends and businesses, as they seek to support the education of everyone in need of help to meet their higher education goals."

Louisiana parents or guardians interested in sending their children to college should begin saving now, if only a few dollars a month, according to David Roberts, LOSFA Assistant Executive Director of Marketing and Outreach.

Roberts will travel to media outlets across the state, between September 6 and September 20, in an outreach effort on behalf of the START Saving Program. During the media tour, Roberts will inform parents and guardians of Louisiana children about saving for college and how to earn a definite financial return on their investments despite the nation's unstable economy.

"The purpose of our media tour is to impress upon parents the immediate need to begin saving for their children's college education," Roberts said.

"Many parents don't realize it, but if they start saving for college early enough, setting aside \$25 each month can cover much of the cost of an education at a public, four year university in Louisiana," Roberts said, "with the rest covered by TOPS and other federal and state aid."


