They've taken the lessons we learned from teachers, Explorer's Club Sponsors, On-site school coordinators and the students themselves to align the areas eligible for funding with the needs of the schools and the philosophy of Louisiana Believes.

Our remaining divisions, SG, IT, START and Fiscal are busy making sure that processes are in place for getting funds to schools and information to students and parents to facilitate a smooth financial transition into this academic year. As recently as yesterday, a request we received regarding START resulted in a revised and streamlined process. In a similar vein we received a request from a school that, by the school's own admission, was in an impossible situation. While this may be true in many cases, in this instance our SG Director took ownership, made phone calls, made more phone calls and identified a solution. How many students did it help: ONE. What was the value of the time for that ONE student: PRICELESS©

Admittedly, the work we do in the field of college access is challenging at best. The fun never stops and just when you think you've read it all, someone comes up with a problem so complex it affirms that truth is indeed stranger than fiction. That's when we reach for the most important feedback of all: the words of the students we serve. LOSFA Launches Louisiana Connect Public Landing Pages

The Louisiana Office of Student Financial Assistance (LOSFA) today announced the launch of the new public landing pages for the Louisiana Connect college access and career planning Web portal.

Although students in grades 8-12 and their parents are encouraged to create accounts and log in to the portal at all times, those without log-in access may now use the redesigned, newly-launched Louisiana Connect public pages to view a comprehensive collection of information needed for college and career planning.

These public pages are separated into three distinct pathways to help users of all ages find the information they need to pursue a college education or career. The three pathways, Plan to Geaux, Pay to Geaux, and Geaux to Work, are further divided by target audiences, including middle school students, high school students, middle school parents and mentors, high school parents and mentors, and adult learners.

Each pathway offers the target audiences important information about different aspects of college and career access.

Plan to Geaux

This section of the public pages is designed to help students and those invested in their success to identify career interests and the specific type of education and training they will need to succeed.

Pay to Geaux

Paying for an undergraduate degree, a graduate program or a technical certificate can be stressful. This section of the public pages offers information about college costs, financial aid, scholarships and more.

Geaux to Work

Career planning is important at all stages of life. This section of the public pages provides information and resources needed to build your path and see your career dream become a reality. Integration with the Louisiana Workforce Commission and its Star Jobs database provides easy access to career information.



Also available on the public pages is an "additional information" area, which offers more information about the Louisiana Connect portal to potential users as well as links to additional college and career access resources available throughout Louisiana.

Federal Student Aid Update

The Impact of Sequestration on Federal Student Aid Programs

On August 2, 2011, Congress passed the Budget Control Act of 2011, which put into place automatic federal budget cuts, known as a "sequester," to take effect if Congress failed to enact legislation to reduce the federal deficit by March 1, 2013. Because Congress did not act, these budget cuts are now in effect and they have had an impact on certain federal student aid programs.

Pell Grant Program

- The law specifically exempts the Pell Grant Program from the effects of the sequester.
- Therefore, the maximum Pell Grant award for the 2013–14 award year remains at \$5,645.

Direct Loan Program

- While this law does not otherwise change the amount or terms or conditions of Direct Loans, it does raise the loan fee paid by borrowers for Direct Loans disbursed after March 1, 2013.
- For a Direct Subsidized or Direct Unsubsidized Loan, the loan fee will increase from 1.0 percent of the principal amount of a loan to 1.051 percent. For example, the fee on a loan for \$5,500 will be increased by \$2.80 from \$55.00 to \$57.80.
- For Direct PLUS Loans for both parent and graduate student borrowers, the loan fee will increase from 4.0 percent to 4.204 percent.
 For example, the fee on a \$10,000 Direct PLUS Loan will be increased by \$20.40 from \$400.00 to \$420.40.
- The Department of Education will be notifying borrowers individually of these fee increases and providing them with additional information

Iraq and Afghanistan Service Grants

The Iraq and Afghanistan Service Grant is provided to certain students whose parent or guardian was a member of the U.S. armed forces and died as a result of military service performed in Iraq or Afghanistan after the events of 9/11. Award amounts for any Iraq and Afghanistan Service Grant that is first disbursed after March 1, 2013 must be reduced by 10.0 percent from the award amount for which a recipient would otherwise have been entitled. For example, the 2012–13 maximum award of \$5,550 is reduced by \$555.00, resulting in a maximum award amount of \$4,995.00; and the 2013–14 maximum award of \$5,645 is reduced by \$564.50, resulting in a maximum award of \$5,080.50.

Teacher Education Assistance for College and Higher Education (TEACH) Grants

The TEACH Grant program provides grants to students who are completing, or plan to complete, coursework needed to begin a career in teaching and agree to teach, for at least four complete academic years, in a high-need field at an elementary school, secondary school, or educational service agency that serves students from low-income families.

Award amounts for any TEACH Grant that is first disbursed after March 1, 2013 must be reduced by 6.0 percent from the award amount for which a recipient would otherwise have been eligible. For example, the maximum award of \$4,000 is reduced by \$240, resulting in a maximum award amount of \$3,760.

Will I be successful?


Although I am ready to grow up
