From the Desk of the Executive Director

Happy Independence Day! Our great nation is celebrating its 235th birthday this month. I'm giving away my age, but it seems like just yesterday we were watching those "Bicentennial Minutes" that dominated the airwaves back in 1976 (am I the only person who remembers those?) Anyway, a mid summer break is so welcomed right now, and I'm sure you are all feeling the same. Hope you enjoy it despite the heat!

July marks the midway point of our calendar year and represents the beginning of a new state fiscal year. The legislature has done their work and we have a budget that did not further cut higher education. Students, however, will see increases to their tuition based on prior year's legislation. On June 15, 2011, the Joint Legislative Committee on the Budget approved tuition increases for public postsecondary institutions as authorized by Act 915 of the 2008 Regular Session of the Legislature. This is the final year of this authorizing legislation that allows schools to increase tuition by 3, 4, or 5% based on SREB peer institution comparisons. On June 23, 2011, the Board of Regents approved each campus's performance measures as required under the 2010 GRAD Act, allowing those schools to increase tuition, not to exceed 5%, for the 2011-12 academic year. The combination of these two could result in up to a 10% increase to tuition at 4 year public institutions. Also, HB 526 that will equalize tuition across the community colleges was signed by the Governor on June 24th. Our office has all the pieces to finally get the TOPS Tuition amounts for 2011-12 out to the campuses and they will be sent out as soon as the figures are complete. A legislative update is provided in this issue of the LOOP for those keeping score.

June 30, 2011 marked the deadline for the application period for our newest program, the John R. Justice Student Loan Repayment Program. In the very first year of its existence in Louisiana there have been more than 50 applications submitted. This program will afford some relief from student loan debt to a select group of dedicated lawyers. These lawyers have bypassed more lucrative opportunities to serve the public as prosecutors and public defenders. They have paid the same law school tuition as their fellow students, incurring the same levels of debt while accepting much lower salaries as public servants. LOSFA is pleased to be able to administer this program on behalf of the US Department of Justice.

Many of you are unfamiliar with the people who serve as members of the Louisiana Student Financial Assistance Commission and the Louisiana Tuition Trust Authority. These Commissions direct the

Youth learn about Chafee Program

Fifty foster care youth and their case workers learned about the benefits of the Chafee Education and Training Voucher (ETV) Program, as well as about general financial aid, from LOSFA's Public Information and Communications Representative Kate Herke at a luau held at Cafe Hope in Marrero. National Youth in Transition, an organization that helps foster care children who are aging out of the system adjust to living independently, hosted the event.

The Chafee ETV Program awards up to \$5,000 annually to qualified students who have been in the foster care system so they can pursue an academic college education or technical and skill training in college to be prepared to enter the workforce.



Jump\$tart Poster Contest Winners




Overall winner: Robin Miller, 11th Grade, Edna Karr Charter High School, New Orleans

Elementary School Winner: Sydnie Larkins, 3rd Grade, St. Aloysius School, Baton Rouge




TRAILBLAZER CAMP 2011

NORTHWESTERN STATE UNIVERSITY -- JULY 10 -12

NICHOLLS STATE UNIVERSITY -- JULY 17 - 19

It's Trailblazer time again and this year, 233 students from across the state have registered for the 2 camps - 132 at Natchitoches and 101 at Thibodaux. These students will be trained to assist their school counselor in planning financial aid awareness and college access information events for their school. They will receive training on a variety of subjects like TOPS, FAFSA, Financial Aid, College Goal Sunday, Financial Literacy and other LOSFA programs. Like last year, this camp will be very interactive - with breakout sessions in computer labs on a variety of subjects such as Financial Aid on the Internet, Career Choices and the new Louisiana Connect Web portal.

The students will also have the opportunity to make a video highlighting what they have learned about financial aid and college access. The purpose of this video is to convince all high school students that any Louisiana student CAN and should go to college, regardless of their financial situation or the financial situation of their family. Changes to START Saving Program

Effective July 1, 2011, each deposit in the Vanguard Total World Stock Index Fund, Investor Shares (VTWSX), will incur a one-time purchase fee of one quarter of one percent (0.25%) which will be deducted from the amount of the deposit.

Effective July 1, 2011, the Louisiana START Saving Program will substitute a lower cost share class for five (5) of the existing program Funds. Since this is only a change in share class of each of the listed Funds, the risk level for each of the Funds remains the same. Changes to Early START

The Louisiana Student Financial Assistance Commission at its June meeting approved an increase in the amount Louisiana Technical College campuses are paid for providing Early Start courses.

The change in payment provides the same \$100 per credit hour award amount for students enrolled at Louisiana Technical College campuses as at other institutions beginning with the fall semester of 2011. The total paid per student per semester remains at \$300.
