Dr. Sujuan Boutté Many years ago when I was a classroom teacher, this was my philosophy. It was something I believed and implemented in my classroom then and it is something I carry with me now. Our Field Outreach Services staff team is on the road putting Franklin’s words into practice! Whether we see them leaving the office at 6am or returning from the road at 9pm, the excitement and passion they display for their work is awesome and contagious.

What’s the lesson and how are we getting students involved? The lesson is LOSFA’s 5-Point Match which is central to LOSFA’s Senior Game Plan. We get students involved by engaging them in active learning sessions during pep-rally style events called College Kick-Offs.

College Kick-off serves as the platform to unveil LOSFA’s year-long plan, known as the Senior Game Plan. The Senior Game Plan is set to a football theme. We are encouraging students to Kick-Off Their Futures; Learn the Plays; Avoid Fumbling the FAFSA and score a Touchdown by matching, applying and getting accepted to the postsecondary institution that will help them launch a career that allows them to get paid to do what they do best!

The Game Plan assists students with the step-by-step process of transitioning into postsecondary education. Elements of the 5-Point Match are taught through a relay game involving students in learning about ways to get connected to the postsecondary institution that best fits their needs.

The LOSFA coordinators work with school personnel to encourage the involvement of the school band, spirit groups and the area Trailblazer leaders. Our Trailblazer leaders have kicked the event off at some high schools and led the discussion on TOPS at others!

Our team members have been on the road non-stop the entire month of September conducting College Kick-Off events at Concentrated and Intensive services schools. The response was so overwhelming from the schools that the September event had to be carried over into October just to get to everyone who wanted to be on the schedule!

Those of us back at the office are able to get the feel for what students are doing and saying by following the events on our social media platforms. Students are encouraged to share their vocal and prose talents improv style as they relate the college message back to their peers and the videos of these impromptu performances are fun to watch! October is Louisiana College Application Month

October has been proclaimed “Louisiana College Application Month” by Governor Bobby Jindal.

Louisiana College Application Month is coordinated by the Louisiana Office of Student Financial Assistance (LOSFA) in partnership with the University of Louisiana System, Louisiana Board of Regents, Louisiana Education Loan Authority (LELA), Council of Student Body Presidents (COSBP), Louisiana Association of Collegiate Registrars and Admissions Officers (LACRAO), Louisiana Association of Independent Colleges and Universities (LAICU), the Louisiana Community and Technical College System (LCTCS), the Lafayette GEAR UP program, and Louisiana TRIO programs.



Louisiana College Application Month is being held at high schools across the state throughout the month of October. As part of the American College Application Campaign (ACAC) initiative, Louisiana College Application Month seeks to increase the number of students who are applying to college early in their senior year with a focus on first-generation and low-income students as well as students who may not otherwise apply to college.

As stated in 2014 by former Louisiana State University Associate Vice Chancellor of Enrollment Management, Dr. David D. Kurpius, applying before November of the high school senior year:

- Increases your opportunity to get the on-campus housing you desire
- Increases your opportunities for high-performing student programs

- Increases your chances for admission to the Honors College
- Increases your opportunities to be considered for discipline (major) specific scholarships
- Increases the assistance you will get from the university to help you enroll
- Increases your opportunities to participate in pre-college programs

LOSFA Executive Director, Dr. Sujuan Boutté, added, “Applying early also increases your chances of being accepted to your first choice school; increases your likelihood of being able to apply and be accepted to summer bridge programs that allow you to get a head start at the institution; and increases your ability to plan in advance for any

fees associated with enrollment-which occur before scholarships, grants and loans are disbursed.”

During Louisiana College Application Month, students at participating high schools will be assisted as they complete college applications during the school day with the goal of each participating student submitting at least one college application. During Louisiana College Application Month, students may apply to any of Louisiana’s 10 community and technical colleges, 10 independent colleges, and 18 public universities.

In part, the Governor’s Proclamation reads, “Whereas the Louisiana Office of Student Financial Assistance (LOSFA) in collaboration with other state agencies,

higher education institutions and college access programs are working together to connect learners with opportunities for greater access, persistence and demonstrable success across the state; and whereas, all Louisiana high school seniors may participate in this initiative, thereby receiving assistance from trained school staff and volunteers in completing a college application; now, therefore, I, Bobby Jindal, Governor of the State of Louisiana, do hereby proclaim October 2015 as LOUISIANA COLLEGE APPLICATION MONTH in the State of Louisiana.”

According to the United States Department of Education, young adults with postsecondary credentials earn more than those with just a high school diploma or its equivalent. College is defined as any education beyond high school. “Thus,” Dr. Boutté added, “there are many college paths ranging from certificates and credentials to four-year degrees; all of which can be paid for with various LOSFA awards. Whether you start with TOPS Tech Early Start in high school and earn up to 24 hours of college credit in a top-demand occupation; TOPS Tech to earn a two-year degree; or TOPS to enroll

in and complete a four-year degree: It’s your choice, it’s your future, and you can count on LOSFA to help.”

In 2014, during the month of October, 3,437 seniors at 57 high schools in 25 parishes completed 4,066 college applications as part of Louisiana College Application Month.

As compared to a pilot College Application Week conducted in 2013, the 2014 figures represent a:

- 128% increase in the number of participating high schools
- 127% increase in the number of participating parishes
- 165% increase in the number of participating students
- 188% increase in the number of applications completed and submitted

State Department Scholarships for High School Study Abroad

The U.S. Department of State recently announced scholarships for American high school students to study abroad.

Applications are now being accepted for several study abroad programs for U.S. high school students. These merit-based scholarships include international airfare, tuition, and program costs, as well as meals and living accommodations (often with a host family). The programs have no language prerequisites, and gap year students are encouraged to apply as long as they meet the age requirements.

Please note that each program has a separate online application process, and application deadlines vary from late October through early January. Visit the program websites or www.exchanges.state.gov for specific information and application deadlines.

- The National Security Language Initiative for Youth (NSLI-Y) offers merit-based scholarships to study one of seven critical foreign languages: Arabic, Chinese, Hindi, Korean, Persian (Tajiki), Russian, and Turkish. The

NSLI-Y program is designed to immerse participants in the cultural life of the host country, provide formal and informal language practice, and spark a lifetime interest in foreign languages and cultures. The application deadline for summer 2016 and academic year 2016-17 programs is October 29, 2015. Visit www.nsliforyouth.org for more information.

- The Kennedy-Lugar Youth Exchange and Study (YES) Abroad Program offers merit-based scholarships to spend an academic year in countries that may include Bosnia & Herzegovina, Ghana, India, Indonesia, Macedonia, Malaysia, Morocco, Philippines, Senegal, Thailand, and Turkey. This program increases understanding between people in the United States and people in countries with significant Muslim populations. Students live with host families, attend local high schools, do community service, and complete a capstone project. Applications for academic year 2016-17 programs are due December 1, 2015. Visit www.yes-abroad.org for more information.

- The Congress-Bundestag Youth Exchange Program (CBYX) offers merit-based scholarships for

an academic year in Germany. The program was established in 1983 to celebrate German-American friendship based on common values of democracy. Students live with host families, attend local schools, and participate in community life in Germany. For more information and application deadlines, visit the organization in charge of recruitment for your state at www.usagermanyscholarship.org. Deadlines for U.S. applicants range from December 1, 2015 to January 15, 2016, depending on state of residency.

FAFSA Changes for 2017-2018 Announced

On Sept. 14, 2015, President Obama announced significant changes to the *Free Application for Federal Student Aid* (FAFSA) process that will impact millions of students. Starting next year, students will be able to:

- **Submit a FAFSA Earlier:** Students will be able to file a 2017–18 FAFSA as early as Oct. 1, 2016, rather than beginning on Jan. 1, 2017. The earlier submission date will be a permanent change, enabling students to complete and submit a FAFSA as early as October 1 every year.

- **Use Earlier Income Information:** Beginning with the 2017–18 FAFSA, students will report income

information from an earlier tax year. For example, on the 2017–18 FAFSA, students (and parents, as appropriate) will report their 2015 income information, rather than their 2016 income information.

The FAFSA is the application that college or career school students must complete to apply for federal student aid, which includes Pell Grants, federal student loans, and work-study opportunities. In addition to determining eligibility for federal student aid, FAFSA information is used by many states, colleges, career schools, and private organizations to determine

eligibility for nonfederal student aid. Completing the FAFSA is the gateway to accessing funds for college for approximately 20 million students each year.

The FAFSA is currently available for applicants to complete on January 1 for the upcoming application cycle. However, many deadlines for state aid are as early as March. For some students, the current FAFSA application cycle is not aligned with college admissions application deadlines, which typically occur in the fall prior to the FAFSA launch. As a result, time is a critical factor for applicants qualifying for aid. Finally, in addition to the timing of the launch of the FAFSA, the availability of an applicant’s income and tax information may lead students—and, where applicable, their parents—to mistakenly think they are not able to file a FAFSA until they file their tax return. This may cause students to miss out on some federal, state and/or institutional financial aid.

The 2016–17 FAFSA will be the final FAFSA to launch on January 1. Students who need to complete the 2016–17 FAFSA will be able to access and submit the form anytime between Jan. 1, 2016, and June 30, 2017. Beginning with the 2017–18 FAFSA, the start date will

move from January 1 to October 1 of the previous year. This means that students who complete the 2017–18 FAFSA will be able to submit the form anytime between Oct. 1, 2016, and June 30, 2018.

In addition to changing the FAFSA launch date, the requirements for reporting income information is changing. Currently, FAFSA applicants provide income information from the “prior tax year.” For example, 2016–17 applicants must report 2015 income information. Beginning with the 2017–18 FAFSA, applicants will provide income information from one tax year earlier—the “prior-prior” year. This means that the 2017–18 FAFSA will collect 2015 income information. As a result of this change, more students and families will be able to complete their FAFSA using income information imported electronically from the IRS, using the IRS Data Retrieval Tool (DRT), rather than submitting applications with income estimates that may need correcting, or worse, waiting until the previous year’s tax return has been filed.

The following table provides a summary of key dates during the transition to using the early FAFSA submission timeframe and earlier tax information.

Commission Amends Rules to Set the End of Academic Year as the Deadline for Achieving TOPS Annual Renewal Requirements

At its August 20, 2015, meeting, the Louisiana Student Financial Assistance Commission amended the Scholarship and Grant Program Rules to set the end of the Academic Year as the deadline for achieving all TOPS Annual Renewal Requirements: earning 24 Hours and achieving the required cumulative grade point average requirement. This Rule Change is effective beginning with the 2014-15 Academic Year except for those students whose TOPS Status would be adversely affected by applying the new rule. For those students, the rule change will be effective beginning with the 2015-2016 academic year.

LOSFA will reprocess AY2015 Grades with the updated deadline shortly. The records of those students positively affected will be updated, and they will be notified by e-mail. The TOPS Dispositions of all other students will not be changed unless a record fails to complete processing. Those records, as well as records being updated due to the receipt of new grade information and payment requests, may show the following Dispositions:

Disposition 033 Renewal Pending AY Hours.

The student's TOPS Cum GPA is 2.0 or higher but the student earned less than 24 hours through the end of the Spring Semester/Term or Spring or Summer Intersession. Student must earn enough hours by the end of summer to meet the 24 hour requirement. Additional information is provided on the Student Eligibility Page:

- 331 Maintained Continuation GPA*; or
- 332 Achieved Continuation GPA*.

*Both Codes are eligible for Summer Payment, if student is otherwise eligible.***

Disposition 034 Renewal Pending GPA.

The student has earned 24 or more Academic Year Hours and has a GPA of 2.0 or greater, but he does not possess Continuation GPA (2.3 or 2.5, as applicable).

This student is eligible to receive his TOPS Award for summer, if otherwise eligible to receive summer payment. The student must achieve Continuation GPA by the end of the summer.

Disposition 042 Suspended for GPA

Under the new rules, the following apply:

If the student was in good standing for the spring semester, then

421 – Student was in good standing for the spring semester. By the end of spring, student has not earned required hours or grades for continuation but did meet SAP. Summer is payable if otherwise eligible for summer payment.

422 – Student was in good standing for the spring semester. By the end of spring, student has earned the required hours and met SAP, but did not meet the cumulative GPA requirement. Summer is payable if otherwise eligible for summer payment.

If the student was not in good standing for the spring semester, then

423 – Student has not earned the required hours and did not meet SAP. Student must earn at least 24 hours by the end of summer and bring his cumulative GPA up to that required for continuation (2.3 or 2.5, as applicable).

424 – Student has earned the required hours and met SAP. Student must bring his GPA up to that required for continuation (2.3 or 2.5, as applicable).

NOTE: A student's disposition is subject to change throughout the summer. If a student does not enroll during the summer or any intersession after the conclusion of the spring semester, his disposition will remain the same for the beginning of fall semester as it was at the end of the spring semester. However, if a student enrolls in summer or in any intersession

after the conclusion of the spring semester, his disposition may change with every enrollment. For example, at the end of spring semester, student is 033 Renewal Pending AY Hours – Maintain Continuation GPA. Student enrolls in intersession immediately following the spring semester, and at the end of the intersession, his disposition changes to 034 Renewal Pending GPA. Then, he enrolls in summer school and at the end of summer school, his disposition changes to 001 Approved Renewal. Then, the student enrolls in summer intersession, and his status code changes to 042 – Suspended Due to GPA. This is the student’s final disposition going into the fall semester.

***TOPS Tech awards will be paid for summer enrollment if the student has a 2.0 or greater at the end of the spring semester.

TOPS Opportunity, Performance, or Honors Awards

will only be paid for summer under the following circumstances:

- The summer session is required in the student’s degree program for graduation and the student enrolled for at least the minimum number of hours required for the degree program, or
- The student will graduate in the summer session, or
- The courses taken during the summer session are required by the student’s degree program and are only offered during the summer session, or
- The student is enrolled in a technical program on a full-time basis, or
- The student has earned at least 60 hours and has signed an acknowledgement that use of TOPS for a summer will reduce their total TOPS eligibility by one semester/quarter/term.
