INSTRUCTIONS FOR COMPLETING AFFIDAVIT OF RESIDENCY

Please complete the affidavit and sign it in blue or black ink before a Notary Public.

- A parent or the court appointed custodian of a dependent applicant must complete this form. A person claiming to be the court ordered custodian of a student must submit a copy of the court document that establishes custody.
- An applicant who is an "Independent Student" may complete this affidavit in his own behalf. By rule, an Independent Student for the purposes of this affidavit is a student who meets at least one of the following criteria: (1) has been determined independent by a financial aid officer exercising professional judgment in accordance with applicable provisions of the Higher Education Act of 1965, as amended; or (2) is an orphan or a ward of the court or was a ward of the court until age 18; or (3) has legal dependents other than a spouse; (4) is married, or (5) is a veteran of active service in the U.S. Armed Forces (Army, Navy, Air Force, Marines, and Coast Guard).
- To qualify for the Rockefeller State Wildlife Scholarship, at least one of an applicant's parents or the applicant's court ordered custodian or, if the applicant is an independent student, the applicant, must be a resident of Louisiana for at <u>least one year prior to July 1</u> of the award year. This requirement does not apply to a nonresident on active duty with the United States Armed Forces who meets the requirements of Instruction (5), below.
- If the student is the dependent child of a nonresident on active duty with the United States Armed Forces who is stationed in Louisiana under permanent change of station orders and who, not later than one hundred eighty (180) days after reporting to such station, changes his DD Form 2058 in his military personnel records to establish Louisiana as his official legal residence and complies with Louisiana income tax laws and regulations for the time period while stationed in Louisiana, you must check "Yes" in Section E.1 and submit the documents listed.
- If the student is the dependent child of a resident of Louisiana on active duty with the United States Armed Forces who is stationed outside Louisiana, but who claims Louisiana as his legal residence on his DD Form 2058 and who has filed a Louisiana state income tax return for the most recent two years, you must check "Yes" in Section E.2 and submit the documents listed.
