TOPICS:	GO Grant Allocations for 2018-2019

The Board of Regents has approved \$28,429,108 for GO Grant Awards for the 2018-2019 award year, an increase of \$2 million dollars from the previous academic year. Institutions have been allocated an amount based on the same methodology used for 2017-2018. The 2018-2019 GO Grant Allocation schedule is attached to this bulletin. The Board of Regent's GO Grant Framework is outlined in Student Financial Aid Bulletin S2013-01 dated January 29, 2013 which can be found on LOSFA's website at www.osfa.la.gov/MainSitePDFs/S2013-01.pdf.

The following apply during the 2018-2019 academic year:

1. The annual allocation will be used for fall, winter and spring semesters/terms, with no plans to fund summer awards.
2. Due to legislative reporting requirements, it is necessary to continue the fall billing deadline of November 1, 2018 (fall billing corrections deadline, November 16) and a winter billing deadline of January 17, 2019 (winter billing corrections deadline, February 1). The fall and winter deadlines will also allow LOSFA and Board of Regents to better estimate funding availability for subsequent semesters/terms.
3. Late billings for fall, winter and spring semesters/terms will require approval. Approval is not guaranteed.
4. The spring billing deadline is March 25, 2019, since March 24th falls on a weekend (spring billing corrections deadline, April 11).
5. Unused funds will be reallocated after the spring billing deadline. Reallocations made to institutions should be used to award students enrolled in the fall and continued to spring or enrolled in the spring who were eligible for but did not receive a GO Grant because the institution used its full annual allocation.
6. In the event of a reallocation of unused funds, the school(s) receiving the reallocated funding will be provided with a deadline to expend the reallocated dollars.

Prior to determining eligible students for Go Grant awards for the 2018-19 academic year, institutions should review their Go Grant packaging policy and make changes as needed. Any updated policy changes should be noted with a new effective date.
